2. All transactions with AECAA Pty Ltd will be upon the terms and conditions we provided with this application.
3. The title for products and any other goods delivered by AECAA Pty Ltd to the applicant shall remain the sole and absolute property of AECAA Pty Ltd as legal and equitable owner until such time as all money due to AECAA Pty Ltd has been paid to AECAA Pty Ltd and shall be at the applicant's risk from the time of dispatch to the applicant. AECAA Pty Ltd may for the purpose of examination or recovery of its goods enter upon any premises where they are stored or where they are reasonably thought to be stored. If the applicant on-sells the goods then the entire proceeds of the goods will be held in trust for AECAA Pty Ltd and will not be mingled with any other money paid into any overdrawn bank account and will at all times be identifiable as AECAA Pty Ltd's money.
